# Actions from the Meeting - Monday 20th June 2011

# 1. Marches EZ Proposals:

RS discussed the presentation of the proposals for the Marches EZ's to the LEP board which were presented by Stephen Lucas of SQW. It was closely scored but Herefordshire won the opportunity to put in the bid for a Marches Enterprise Zone.

#### 2. SQW Presentation:

SL presented the Herefordshire subset of the information which was presented to the LEP board and highlighted the main aims of an EZ as being to deliver for the whole LEP area:

- Growth
- Jobs (in particular jobs by 2015)
- Demonstrates value for money

The chance of success is in the region of 1 in 3, with the likelihood of up to 35 LEPs bidding for the remaining 10 Enterprise Zones.

Strengths of the Herefordshire proposal were the strong private and public sector support and that it would be easy to start work on site immediately. Herefordshire has good strategic fit in terms of sectoral focus and has growing business areas in defence, high tech environmental technologies, engineering and food & drink.

Weaknesses are identified and will be worked on for the full application, but were around creating jobs to benefit the wider LEP area, confirmation that the landowner is on board, road links to East and North, and quantifying market appetite. SL is confident that this can be overcome with the right presentation and clarifications.

The application has to be in by 28<sup>th</sup> June, with a quick response expected.

**Action: PBL** to circulate a breakdown of the work identified / leads required for the completion of the application (sent 21.6.11)

**Action: PS** leading and liaising with **RG** and **RS**. A formal visit from Rosa at UKTI arranged for 28<sup>th</sup> June, decision on who should attend, **PC** available

**Action: GW** available to brief attendees on UKTI / Defence as necessary

c. Supporting company evidence and sector / targets

Action: GW to circulate a list of Marches defence contractors / businesses

d. Commercial proposition and development

**Action: JB** and Alder King to look at the different opportunities build and buy, build and rent etc.

e. Planning constraints

Action: Dave Nicholson, Herefordshire Council

f. Design/Architectural brief

**Action: JB** To consider sustainability, local sourcing, appearance and consistency of the site(s)

g. Private sector leadership

Action: RG / RS to discuss, relates to governance

h. Deadlines / submissions

**Action: All** draft application responses to be returned to PBL by 4pm (if possible 1pm), 24<sup>th</sup> June

Action: RG / PBL / SL to meet and discuss the draft application pm 24<sup>th</sup> June

**Action: All** Review draft application with responses and comments to PBL / SL by first thing 27<sup>th</sup> June.

Action: SL / PBL to submit complete application form to SQW by close of play 28th June

i. Name of Herefordshire EZ

**Action: All / RJ** Various names were discussed, it was discussed that a Marches branding is important even though the bid is centred on Herefordshire. Suggestions and ideas to be sent to **RJ**.

# 4. Lobbying:

a. MPs

**Action: RP** Has already got a meeting with Bill Wiggin on 21<sup>st</sup> June, important to speak to him as he is whip. RP will also arrange to speak to the other Marches MPs.

b. Council

Action: RP Hold a seminar for all Herefordshire Councillors

c. Central Government (BIS / UKTI)

Action: In hand, visit from Rosa UKTI

d. Defence

**Action: NK** To brief CO at Credenhill. **IH** will also speak with his local contacts in defence.

e. Local PR / Comms

**Action: Heather Gorringe / RJ / John Burnett** In hand, although a protocol needs to be agreed with Shropshire and Telford & Wrekin. Marches LEP has a PR agency working for them, but Herefordshire Business Board also needs to be able to put out their own news items.

PBL has had an enquiry from a food company looking to expand in Herefordshire. It is a new enquiry and is being dealt with by the Economic Development Team.
