Herefordshire "Stop the Drop" Litter Pledge

Over 200 community groups, businesses, Parish and Town Councils have signed the Stop the Drop Litter Pledge which aims to help keep Herefordshire litter-free.

Stop the Drop was launched by Herefordshire Council in 2016 with the aim of encouraging everyone to take more responsibility for their waste by not dropping litter, and organising community litter picks to engender a pride in their local surroundings.

Nuffield Farming Scholarships 2018

Farming is about to face the biggest change for generations. Do you want to be at the front end of those changes?

Since the 1947 Agricultural Act there have been many changes in the way UK farming has had to adapt and over that period several hundred Nuffield Farming Scholars, including over twenty from Herefordshire, have scoured the world for ideas, opportunities and innovations which have helped UK famers to become more proficient.

A Nuffield scholarship is an 'international passport' for global travel which opens doors not usually open and scholars become members of a vast international net-work. No formal post school educational qualifications are required by applicants.

With the imminent changes to the support mechanisms post Brexit, the new era will entail new thinking to counter the loss of CAP support. It will require new approaches related to productivity, volatility, profitability and sustainability, coupled to the envisaged swing towards a more environmentally oriented support system.

When Lord Nuffield established the Nuffield Farming Scholarships in the immediate post war period of food shortages, he did so to enable farmers and others involved in the food chain to seek out ideas world-wide which would help farmers increase food production. Post Brexit the industry will need a new approach to be able to react in a positive way to new scenarios including how to face volatility and how to react to support systems based on environmental payments.

So history will be repeating itself and there will be a need once again to scour the world for new approaches, innovations and new market opportunities.

Are you going to be one of those people between 25 and 45 years old, who would like to go out into the world to gather information and ideas? If so apply for a Nuffield Farming Scholarship. Applications must be in by late July.

New Water Environment Grant (WEG) launched

DEFRA, Natural England and the Environment Agency have launched a new grant scheme to improve the water environment. The scheme will provide £9 million a year for the next three years to applicants applying for funding to works to restore the water environment (rivers, lakes, canals, wetlands etc). Potential projects could include river restoration, removal of obstacles to help fish passage or actions to improve the water quality. Grants will be determined by EA & NE, and funding will be awarded in August 2018. Successful applicants will be expected to start their projects before March 2019, with completion dates of March 2021.

The WEG is now open to eligible applicants, which includes farmers, until 11th May 2018. Guidance and access to application form can be found at:-

Countryside Stewardship: details of new simplified offers

Four new Countryside Stewardship offers have been introduced for farmers and land managers to boost biodiversity and help protect and enhance farmland and the countryside. Significant improvements have been made to the scheme to make it simpler and easier for farmers & land managers to apply.

The four new offers are **Online Arable Offer, Lowland Grazing Offer, Upland Offer** and **Mixed Farming Offer**. All four offers are open for application, and to request an application pack call **0208 026 1089**.

The deadline for submitting your application for each of the four offers is 31st July.

Reminder about Silage Slurry and Agricultural Fuel Oil (SSAFO) Storage Regulations

If you are thinking of building a new silage clamp, slurry tank or lagoon, or substantially altering an existing store, you need to tell the <u>Environment Agency</u> at least 2 weeks before you start construction. You also need to provide information about the structure you are planning to build and where it will be located.

Guidance on GOV.UK at www.gov.uk/guidance/storing-silage-slurry-and-agricultural-fuel-oil sets out the information you will be asked to provide to the Environment Agency. The EA is happy to discuss your proposals with you at an early stage of planning. It can give advice about construction requirements and location if this is needed. Catchment Sensitive Farming

The Countryside Stewardship Scheme has been launched again and the application window for both Mid Tier and Water Capital Grants are now open. If you are a priority farm, your local Catchment Sensitive Farming Officer (CSFO) can visit to give you advice on the scheme (5 year agreements and 2 year capital agreements), and give approval for certain option where necessary. The Prince's Countryside Fund

The Herefordshire Federation of Young Farmers' Clubs (HFYFC) working in partnership with Herefordshire Rural Hub have secured funding to provide support for training in a rurally based career to the end of December 2019. The funding is easy to access. All you need to do is select which course you would like to go on and complete the application form. If your application is approved you will be able to reclaim 70% of your training and test costs, up to a maximum of £250. Applicants must be a current member of HFYFC or a past HFYFC member (up to 40 yrs old).

The fund will support training that will; *improve your employability, increase or improve your skill set, improve your safety or allow you to undertake extra responsibility in your current job.*

The appraisal panel meets on the first Monday of the month. Please ensure that you submit your application in good time before your course is due to take place, as training cannot be funded retrospectively.

The Jack Hughes Fund - administered by Herefordshire Community Foundation

The Jack Hughes Fund will fund up to a maximum of 70% pf the cost of training or costs up to a maximum of £150.

Funding will be limited to one family member/employee per annum

The programme will be available for farmers <u>aged over 40</u> and will specifically provide funds to support those who

- retraining or upskilling as they are leaving the industry
- training to support a new farm diversification enterprise
- training or business support for succession planning

Funding will also be available for the following courses:

- Safe use of pesticides PA1, PA2, PA6
- Rodent control on farms
- · Emergency first aid
- Food safety (Basic Food Hygiene)
- Chainsaw Maintenance & Cross Cutting (CS30)

The funding is easy to access, but please note that the project will not support training retrospectively and places will be limited. Applicants need to be resident in Herefordshire.

RDPE Countryside Productivity Scheme

Funding for projects in England which improve productivity in the farming & forestry sectors & help create jobs and growth in the rural economy. It is administered by the RPA. Under the RDPE Countryside Productivity Scheme, there are grants for:

- Water resource management and reservoirs (application deadline 29th June 2018)
- Adding value to Agri-food products (application deadline 29th June 2018)
 Grants to fund projects that improve the processing of primary agricultural products (i.e. Annex I products), benefiting the Agri-food supply chain which will in turn improve farm productivity.
- Improving Farm Productivity (application deadline 3rd December 2018)

 Grants to fund projects that improve farm productivity through the use of robotic equipment and systems to aid crop and livestock production; increasing the use of renewable energy produced on farm; the use of LED wavelength controlled lighting to aid crop production; more efficient use of livestock slurries and manures, and digestate.

The RDPE Growth Programme administered by DEFRA

Food producers and processors and horticulture businesses are being urged to submit applications for EU funding to help their organisations grow before the 2018 deadline. Companies operating in the food sector including businesses involved in meat processing, yoghurt and cheese production, egg packing, food and drink processing and storage facilities, and dairy, fruit or grain production can apply for grants to support their growth plans.

Funding could pay for constructing or improving buildings or buying new equipment and machinery. It will be awarded to projects that increase productivity, adopt new techniques, processes or innovations, and those that create business efficiencies, new jobs or new joint ventures and partnership working within a supply chain.

Grants can cover up to 40 per cent of eligible project costs with a minimum grant of £35,000 and a maximum grant of £170,000. Expressions of Interest for funding bids must be submitted by 31st May 2018.

Rural & Business Matters Whilst Police rural crime operations continue, so do rural thefts! We need your support to tell us about anything you think is suspicious (behaviour, person, vehicle) on your land or in or near your business and home. This enables us to target our resources more effectively. It can be very frustrating when you make a call and the response is not always as you would like it to be, however, be assured EVERY call or piece of information received is looked at for the potential to develop a better intelligence picture.

<u>Prevention is better than replacement!</u> Your Rural & Business Officer (Paul Crumpton in Herefordshire) can provide you with Crime Reduction advice - Free of charge !...If you would like some advice contact Paul direct (details below).

<u>Home security</u> Remember your shed or other outbuildings as well as your home. Mark your garden, garage or workshop tools with an overt security marker to make them less attractive to the thief and very identifiable to you. Make sure you note down the make, model and serial numbers, ideally with an image too! And use the Free online national property database at https://www.immobilise.com/

Fraud & Scams Online, on the phone, or at your door, the crooks are sometimes able to get sensible people to do things they would not normally do, like giving bank details to a complete stranger. So, think of two words UNEXPECTED & URGENT. If you receive a phone call, an email or a caller at the door that was UNEXPECTED who is requiring some URGENT action from you, STOP. Decline whatever is being offered or suggested and establish in your own time if you need to address whatever the caller was engaging you in.
